I understand my financial aid is not complete until I receive my award notice from Central Alabama Community College (CACC). I also understand if the tuition due date arrives before I receive my award notice, I will be required to pay any outstanding tuition and fees by the advertised due date.

Each eligible student will receive an award notification via MyCACC after file completion. Any financial aid award exceeding tuition, fees, and other allowable charges will be disbursed via postal mail to my address on file in the Admissions Office. The Business Office will mail financial aid refund checks approximately three weeks after the first day of class.

Your Federal Pell Grant Award will be based on full-time enrollment and will be prorated for enrollment of less than full-time. Federal financial aid will only be paid for courses required for your program of study. (Please contact an academic advisor regarding program requirements.)

Your financial aid award may be reduced accordingly if you fail to begin attendance in classes, withdraw from classes, and/or enroll for classes not required for your declared program. You may be obligated to repay the difference between the amount of funds awarded and the recalculated amount. If you completely withdraw or stop attending school prior to completing more than 60% of the length of the term, you may owe a repayment of financial aid monies back to the College or the Department of Education in accordance with the Title IV Refund calculation.

The Financial Aid Office will update your FAFSA as needed in order to package your financial aid award. The Financial Aid Office reserves the right to modify or cancel your financial aid award due to changes in your academic status, your remaining need, or funding you received by Central Alabama Community College (CACC) or another institution of higher learning.

Your acceptance of these Terms and Conditions indicates you understand you must comply with CACC's Satisfactory Academic Progress (SAP) policy. Failure to do so may result in loss of financial aid eligibility. The three key components of the SAP policy are (1) program completion, (2) required credit hours, and (3) required grade point average (GPA).
