CACC has received CARES American Rescue Plan Act of 2021 (HEERF III) funding.*

The American Rescue Plan Act of 2021 requires us to review enrolled Summer students' exceptional need status to determine eligibility. Form A - If you are a **DEPENDENT** student (under the age of 24, not married, not a veteran, have been an orphan/ward of the court/foster care, legal guardianship, homeless, or an emancipated minor) you will need to complete this form with electronic signatures for you and your parent and submit it for review. If you (or your parent) have not completed an electronic dynamic form, you will have to create an account.

Form B - If you are an **independent student WITHOUT** dependents (children/other dependents), you will need to complete this form with your electronic signature. If you have not completed an electronic dynamic form, you will have to create an account.

Form C - If you are an **independent student WITH** dependents (children/other dependents) that you provide more than 50% of the support, you will need to complete this form with your electronic signature. If you have not completed an electronic dynamic form, you will have to create an account.
